

Duct Leak Repair or Replacement Rebate

To apply for your \$150 rebate, please carefully read the information below, then complete the **Rebate Request Form**.

Rebate Requirements:

- Please refer to the Energy Efficiency Rebate Policy below for complete details.
- To encourage the sealing of leaks to improve efficiency and performance of Heating and Air Conditioning Systems in existing residential homes.
- Valid only on existing air conditioned homes. Does not apply to new construction homes.
- Equipment must be installed in accordance with the manufacturer's recommendations.
- Ducts must be sealed using mastic or a combination of mastic duct sealant and mesh, pressure sensitive foil tape (UL 181AP) or heat sensitive foil tape (UL 181AH). If a foil tape is used it must be applied in a manner such that the duct board scrim pattern is visible through the tape. Duct mastic sealant should be used whenever possible.
- Rebate form must be completed and submitted to KEYS along with proof of purchase within 90 days of installation. Contractor must itemize the inspection and repair portion of the service on the invoice.
- Rebate Amount: Up to \$150
- Limit one rebate per residential customer account every five years.
- Onsite verification of installation may be required.
- Rebate will not exceed purchase price.

Energy Efficiency Rebate Policy:

Section 1. Overview

Utility offers conditional rebates to qualifying customers as an incentive to install qualifying ENERGY STAR® equipment and/or appliances (referred to in this Policy as "Qualifying Energy Efficient Equipment"). Customers benefit from Qualifying Energy Efficient Equipment through utility bill savings and sound environmental stewardship; Utility benefits by reducing its peak demand and reliance on power production from fossil fuels.

Section 2. Program Eligibility Criteria and Requirements

The following criteria and requirements must be met for a customer to be deemed eligible for a rebate.

2.01. Eligible Participants

- Only residential retail electric customers of record may qualify for a rebate.
- The Qualifying Energy Efficient Equipment must be located on the customer's premises, and within Utility's service territory, and must receive retail electric service from Utility.

2.01.1. Application

- An application for a rebate must be completed and approved by Utility.
- A copy of the proof of purchase by customer from an established vendor must be attached, mailed, and received by KEYS within 90 days of purchase. The proof of purchase must include the customer name, address, and date of purchase.

2.02. Additional Terms; Rebate Credit

- KEYS reserves the right to
 - Withhold payment of any rebate until any identified problems with the applications are resolved.
 - Terminate this rebate in whole or in part due to the recipient's failure to fulfill the terms and conditions in this document, or due to non-appropriation of necessary funds.
 - Alter the rebate program at any time and without notice to customer.
- All rebates are subject to funding availability. KEYS may cancel a rebate at any time prior to payment, without notice, due to lack of available funds.
- Rebates may take up to 4 weeks to process.
- The amount of the rebate will be credited to the energy bill of the customer of record.

2.03. Limit of Liability; Indemnification

- In no way shall KEYS be liable for, and Customer hereby agrees to indemnify, defend and hold harmless KEYS, its subsidiaries or affiliates, and their respective employees, officers and directors, from and against any and all liability, loss, damage, cost or expense, including attorney's fees, that may be caused by, due to, occasioned by, or otherwise arising out of the installation, operation, mis-operation, or use of Customer's Qualifying Energy Efficient Equipment.
- Customer acknowledges and agrees that in no event shall any statement, representation, or lack thereof, either express or implied, by KEYS, relieve the Customer of exclusive responsibility for the Customer's system. Specifically, KEYS approval of the rebate application, payment of the rebate, or any KEYS inspection of the Qualifying Energy Efficient Equipment shall not be construed as confirming or endorsing the Equipment design or its operating or maintenance procedures nor as a warranty or guarantee as to the safety, reliability, or durability of the Qualifying Energy Efficient Equipment.

2.04. Renewable Energy Credits; Green Attributes
